- 2. I am the appointed Chapter 7 Trustee in the above-captioned bankruptcy case.
- 3. I make this declaration to support the First Interim Application of Paul M. Healey & Sons CPAs, Ltd. for Allowance of Compensation for Services Rendered During the Period From February 13, 2015 Through February 20, 2017 and For Reimbursement of Expenses Pursuant to 11 U.S.C. §§ 330 and 331 and Federal Rule of Bankruptcy Procedure 2016 (the "Fee Application").1
- 4. On January 9, 2015 (the "Petition Date"), AMERI-DREAM REALTY LLC (the "Debtor") filed a voluntary petition under Chapter 7 of the United States Bankruptcy Code [ECF No. 1².
- 5. On January 9, 2015, I was appointed as the Chapter 7 Trustee in the Debtor's bankruptcy case.
- 6. Following my appointment as Chapter 7 Trustee in the Debtor's bankruptcy case, I determined that I would require the assistance of an accountant to prepare tax returns on behalf of the Debtor's bankruptcy estate and otherwise assist me in fulfilling my statutory obligations under Section 704.
